3. **Consider, possible action to Approve Minutes of the July 25th and 27th 2022 meetings**

12. Manager's comments

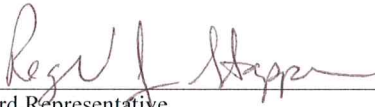
Meredith gave updates on District Activity, including the presentation to the 4-H Water Ambassadors.
